FREQUENTLY ASKED QUESTIONS

HOW CAN I STAY UP-TO-DATE AND INFORMED ON VILLAGE NEWS?

You may also sign up for “Hobart Headlines,” a bi-weekly e-newsletter that contains interesting and relevant information for Hobart residents. To sign-up, please visit www.hobart-wi.org and click on “Hobart Headlines” on the right portion of the page to sign-up!

WHAT SCHOOL DISTRICT DO I LIVE IN?

Hobart has two school districts, Pulaski and West DePere that serve Hobart students. Please call the Hobart Village Office 920-869-1011, or contact the schools for information on which school serves the district you will be residing in. The Pulaski phone number is 920-822-6000; West DePere phone number is 920-337-1393. Generally, HWY 54 is the dividing line (but not exactly) with Pulaski to the north and West DePere to the south. Please call the office or stop in at our office to check out the map if you need more detailed information.

DO I HAVE TO HAVE A DOG LICENSE?

Yes, annual licenses are required by the State of Wisconsin. Proof of current rabies vaccination is required for issuance of the license. The cost for dog licenses is \$5.00 for neutered or spayed animals and \$10.00 if they are not altered. Deadline for licenses each year is March 31st. After this date there is a penalty of \$5.00 per animal. Dogs are required to be confined on their owner’s property, and not to run at large.

A dog that is actively engaged in a legal hunting activity, including training, is not considered to be running at large if a dog is monitored or supervised by a person and the dog is on land that is open to hunting or on land on which the person has obtained permission to hunt or to train a dog. We do have a trail at the Four Seasons Park where you may walk your dog on a leash. We ask that you do keep your dog on a leash and clean up after it on the trail only so this privilege may be continued.

WHERE DO I REGISTER TO VOTE?

You may register at the Village Office, 2990 S. Pine Tree Rd., Hobart, WI or by mail by downloading the registration form from our website www.hobart-wi.org and supplying the proper identification along with the completed form to the office staff. We have included the registration form in this welcome packet. *Please note that Voter I.D. is also required to vote.*

WHERE DO I VOTE?

The polling place for the Village of Hobart is located at 760 Airport Drive, at the Woodland Worship Center. Poll hours are 7:00 am to 8:00 pm on Election Day.

I AM A NEW RESIDENT, MAY I VOTE?

If you have lived in the Village of Hobart for a minimum of 28 days prior to the election, you may register and vote. You will need to bring proof of residency to the polling place to register and vote on Election Day. *Voter ID is also required to vote. Visit the Village website to make sure you have the proper ID.*

HOW CAN I PARTICIPATE IN LOCAL GOVERNMENT?

Hobart values an interactive government with its residents, and maintains several standing committees that involve resident participation and input. We have a Planning and Zoning Committee, Site Review, Public Works and Utilities Advisory Committee, Police Commission, Fire Commission, and Community Development Authority. If you have interest, experience or expertise in any of these or other local government issues, please contact our Village Clerk at 869-3802.

HOW DO I GET RID OF LARGE ITEMS, CARPET & PAD, SWING SETS, BIKES, LAWNMOWERS, TIRES, AND GRILLS?

Arrangements may be made to have these items picked up by the Waste Service by calling **Advanced Disposal** at **920-983-3341**. Advanced will bill you directly for the cost of pick-up and disposal of your large items. Large item pick up day is at the discretion of the hauler. You may also dispose of them by taking them to the Brown County Transfer Station located at 3734 W. Mason Street, Hobart, WI. Please call the Transfer Station for charges 920-490-2706. The Transfer Station will not accept cash payments; they only accept check or charge. *You may want to check with your landlord if they have specific arrangements to pick up large items.*

HOW DO I GET RID OF HAZARDOUS HOUSEHOLD WASTE?

Please visit the Brown County Resource Recovery Department's website, www.browncountyrecycling.org, to familiarize yourself with everything that is **BANNED** from the landfill, and must be disposed of properly. They have a Hazardous Household Waste facility that takes almost everything a household uses that may be hazardous. **Please refer to the garbage and recycling document in this packet for more information.**

Wisconsin Voter Registration Application Instructions

Each section on the front side of this document corresponds to the sections below (1-12)

These documents constitute proof of residence if they:

Contain the voter's current and complete first and last name and residential address, and are valid on the day used to register to vote.

Electronic versions are also acceptable.

- A current and valid WI Driver License / ID Card
- Any other official identification card or license issued by a Wisconsin governmental body or unit
- An employee ID card with a photograph, but not a business card
- A real property tax bill or receipt for the current year or the year preceding the date of the election
- A residential lease (Does not count as proof of residence if elector submits form by mail)
- A picture ID from a university, college or technical college coupled with a fee receipt
- A picture ID from a university, college or technical college coupled with an on-campus housing listing provided by the university, college or technical college to the municipality that denotes US Citizenship
- A utility bill for the period commencing not earlier than 90 days before the day registration is made
- (Homeless voters only) A letter from an organization that provides services to the homeless that identifies the voter and describes the location designated as the person's residence for voting purposes
- A bank statement • A paycheck • A check or other document issued by a unit of government

- Fill in the circle (New WI Voter, Name Change, Address Change) describing why you are completing this form.
- A "New WI Voter" is anyone who is not currently registered to vote in Wisconsin. You can check your voter registration status at MyVote Wisconsin website (<https://myvote.wi.gov>)

- If you are registering to vote on Election Day and have been issued a WI driver license or ID, but are unable or unwilling to provide the number, your vote will not be counted unless you provide the number to the election inspectors by 8:00 p.m. on Election Day or to your municipal clerk by 4:00 p.m. the Friday following Election Day.

- Provide your current and complete name including your last name, first name, middle name, and suffix (Jr., Sr., etc.), if any. Please verify you have provided your name as it appears on the document, the number of which you provided in Box 2, if the name on that document is still your current and complete name.
- Provide your month, day, and year of birth.
- Providing your phone number and/or email address is optional and is subject to open records requests.
- A "military elector" is a person, or the spouse or dependent of a person who is a member of a uniformed service or merchant marine, a civilian officially attached to a uniformed service and serving outside the United States, or a Peace Corp volunteer. Military electors are not required to register as a prerequisite to voting at any election.
- A "permanent overseas elector" is a US citizen, at least 18 years old, who does not qualify as a resident of this state, but who was last domiciled in this state, or whose parent was last domiciled in this state immediately prior to the parent's departure from the United States, and who is not registered to vote in any other state.

HEY, WE ARE “HOBART” in Zip Codes 54155, 54115, and 54313!

Decades ago, when the Oneida post office was opened, a wide area around this postal branch was identified as “Oneida.” However, there is NO “Oneida” in Brown County and there never has been. The Town of Oneida is in Outagamie County.

Several years ago, the Village Board and staff worked hard with the Green Bay Post Master to ensure that mailing addresses within the jurisdictional boundaries of the Village of Hobart, would be acknowledged as “Hobart, WI” for Zip Codes 54155, 54115, and 54313. Things get confusing when folks continue to use “Oneida,” “De Pere,” or “Green Bay” for business and residential addresses located in the Village of Hobart in these zip codes.

All residents should use “Hobart, WI” for all personal, business, and property records (ex: all mail, taxes, census, new acquisitions, etc..). The Village would like to firmly state that if any person or entity insists that one cannot use “Hobart, WI” and must use “Oneida, WI,” they are either misinformed or incorrect. **Please call Andrew Vickers at 869-3804, or email at andrew@hobart-wi.org** if any issues should arise that you would like assistance with.

Why is it important to acknowledge Hobart as home? We’re attracting new businesses regularly, we’re the fastest growing community in Brown County, AND - - our quality of life and rural environment is something to truly brag about!

Don't Flush Disposable Towelettes

Increasingly popular cleaning wipes, pre-moistened towelettes such as [Handiwipes](#), [Clorox Clean Ups](#), baby wipes and [Swiffer](#) products, which are often advertised as flushable are being blamed for creating sewer system clogs and back-ups in municipalities across the nation. While these products provide convenience, they do not readily break down and dissolve in sewer systems, unlike toilet tissue and Kleenex. The result is costly sewer clogs and back-ups, which can lead to sewage back up into area basements.

Additionally these products have resulted in costly modifications to existing sewer system infrastructure. In recent history the Village expended over \$20,000 retrofitting one of its sewage lift stations due to pump clogs attributed to towelettes being experienced as frequently as twice a week. The retrofit involved replacing the pumping system with pumps utilizing newer technology designed to resist clogging.

While the retrofit has significantly reduced the frequency of clogs, this is an expense that would not have been pursued until the pumps had reached the end of their useful life. Clogs experienced in our sewage system put residents at risk of sewage back-up and results in maintenance costs that would otherwise not be experienced. Recognizing these costs have a direct impact on the sewage rates paid by all customers, *the Village asks all residents and house cleaning services to refrain from flushing these products down the toilet.*



Winter Plowing and Parking Regulations

All Night Parking Prohibited

No person shall park a vehicle on any street or road within the Village between 2 a.m. and 6 a.m. from November 1 through March 31 of each year. (§264-3) Hobart Municipal Code

Please do not plow snow across the roadways.

PLACING INJURIOUS SUBSTANCE ON HIGHWAY: No person shall place or cause to be placed upon a highway any foreign substance, which is or may be injurious to any vehicle or part thereof. (§346.94) miscellaneous prohibited acts; Wisconsin State Statutes:

SEVERE WEATHER WARNINGS IN THE VILLAGE

The Village of Hobart currently has one tornado siren located at Fire Station #1 on S. Pine Tree Rd, south of the Village office. The tornado sirens utilized in Brown County have a coverage area of 1 to 1 ½ miles.

Alternative Weather Warning Options

You may purchase a “weather radio” through Brown County Emergency Management. The county sells Midland, model WR-100 weather radios at a cost of \$30 plus tax. Features of this radio include: tone alert, specific area messaging and battery back-up. It is important to note, that unlike the traditional media people use to remain aware of severe weather, weather radios function even when we experience power outages. Area hardware stores also retail weather radios with additional features other than the features offered by the Brown County Midland WR-100 radio. Should residents have questions regarding weather radios, please contact Paul Gazdik at Brown County Emergency Management at 391-7431 or Hobart-Lawrence Police Chief Randy Bani at 869-3800. Residents should also investigate their smart phones or other wireless devices that may have downloadable applications to alert them to severe weather in our area.

2016 Garbage and Recycling Information Village of Hobart

- It is the responsibility of your landlord to provide you with adequate garbage and recycling facilities. If your landlord is not providing adequate space or not emptying the designated receptacles frequently enough, *please contact the Village at 869-3815.*
- Please use the brochure included in this packet to educate yourself on what is recyclable and what is NOT recyclable. Brown County has one of the country's best recycling systems, please use it!
- Please take your item large-items to the Brown County Transfer Station located at 3734 W. Mason Street (Hwy 54) - 490-2706. Check with your landlord on their polices and arrangements for large-item pick-ups at your location;
- Hazardous Household Waste is BANNED from the landfill. Below is information on how to dispose of properly:
 - Take your Hazardous Waste to the Household Hazardous Waste Facility located at 2561 S. Broadway, Ashwaubenon - 492-4950.
 - Visit www.browncountyrecycling.org for information on:
 - Items that are banned from the landfill;
 - Hazardous waste and disposal;
 - Information on recyclables.

The Village Business Office, located at 2990 S. Pine Tree Road, offers the following recycling services for common hazardous wastes, for the convenience of residents:

- Batteries (AA, AAA, 6-volt, 9-volt, rechargeable, but NOT lead acid);
- Compact Fluorescent Lamps (CFLs);
- Compact discs, ink and toner, small electronic devices (cell phones, keyboards, etc.);
- Unused or unwanted prescriptions and over-the-counter medications;

Remember: Wisconsin State Law PROHIBITS the disposal of recyclable and hazardous waste goods to be sent to the landfill. PLEASE RECYCLE and be responsible with your waste!



What is the best way to dispose of my paint?

- Latex paint is non-hazardous but represents nearly 30% of all the material collected by the HHW Facility. Full or partly full paint cans may be brought to the HHW Facility though there is a charge for disposal of latex paint.
- If the can has a small amount of paint left in it, sawdust, oil-dry, or cat litter can be used to absorb and dry all the free liquid. The can may then be disposed of with the lid off in your regular garbage.
- If the paint can is empty, let any paint residue in the can dry completely. Dispose of the can in your regular garbage with the lid off.

When properly stored, paint has an amazing shelf life. Oil-based paint can last up to 15 years and latex paint will keep up to 10 years. If paint still mixes smoothly, it can probably still be used. If latex paint has frozen, brush it on a piece of paper. If there are no lumps, the paint can still be used.

What do we do with your Hazardous Waste?

- Most materials, **like paint and solvents**, are bulked into 55-gallon drums. These drums are removed by a hazardous waste contractor who further bulks the material for transportation to a company that uses it as fuel. A cement kiln, for example, is a company that can use this material in a process, similar to incineration, called fuel blending. Fuel blending recovers the heat value, but at the same time the material is destroyed because of the high temperatures.
- Materials, like **pesticides**, are packed into drums called loose packs, which are drums filled with smaller containers. These drums are sent to a disposal company for additional sorting. Some of this material may be fuel blended, but most will be incinerated. Incineration destroys large complex chemicals by breaking them down into small, less hazardous compounds like water, carbon dioxide and ash.
- **Acids and bases** are sent for disposal in lab packs. Lab packs are similar to loose packs, except a lab pack has a container content sheet. This inventory sheet is used to further identify the hazardous components of the lab pack. Corrosives are neutralized to make them non-hazardous.
- **Computers** are sent to a company where they are disassembled. Any non-retaining information parts are reused. Information-retaining parts are shredded before recycling.

What is the Product Exchange Room?

Much of the material brought to the Facility is in very good shape and can still be used. The Facility has a Product Exchange Room where residents are able to pick up items to use for home repairs and projects! Each year more than 150,000 pounds of paint, stains, thinners, pesticides, automotive and cleaning products are taken and reused. You do not need to bring anything to take something; however, we ask that you take no more than 5 items at one time.

Where does Brown County get its funding for the HHW Program?

A unique relationship between the Brown County Port & Solid Waste Department, Green Bay Metropolitan Sewerage District, all Brown County units of government, and the Oneida Tribe of Indians provides a portion of the program's funding. Additional funding is obtained through grants and generated by collecting material from businesses and other Counties. While most products brought in by Brown County Residents are not assessed a fee, there is a **minimal charge for computers, electronics and latex paint**.




