1. Call to Order, Roll Call:

2. Verify/Modify/Approve Agenda:

Motion by Mike Hoeft, seconded by Laura Lear, to approve the agenda as presented. The motion passed unanimously.

3. Public Comment on Non-Agenda Items

4. Approval of Parks & Recreation Committee Minutes:

5. Pedestrian Trail from Birch Drive to Four Seasons Park:

Motion by Jane Jerzak, second by Mike Hoeft, to recommend to the Village Board option 1 of the proposed trail from Birch Drive to Four Seasons Park as presented. The motion passed unanimously.

6. Basketball Hoop at Jan Wos Park:

The committee would like staff to put together cost estimates for a full court and a half court option at the park. They would also like staff to speak with The Workshop to get an idea of what the local desire for a court would be. Staff will bring these results back to the committee at their next meeting.

7. Concession Stand at Four Seasons Park:

The committee reviewed the cost estimates for the concession stand as well as the baseball diamond proposals. The committee would like to wait to see if the Village Board will include the cost of one of the ball diamonds in the bonding for the replacement of Fire Station 1 before making a final decision. The committee also directed staff to gather league interest before committing to building a concession stand near the diamonds. Staff will bring this item back to the committee after the Village Board has made their decision on the bonding.

8. Free Little Libraries:

The committee directed staff to create a form for residents to fill out requesting permission to place a free little library on their property. Staff will create a draft for the committee to approve at their next meeting.

9. Bike Trail from Trenty Trail to Brookwood Circle:

The committee directed staff to gather more details on what the current easement would allow for. They also decided to hold an informational meeting with the residents of Trenty Trail and Brookwood Circle to gather input from all residents affected by this decision. Staff will schedule the meeting and send out notices to the residents.
